

Section J: Important Information on Standard PEI-Student Contract

- (a) As stipulated by CPE with the aim of enhancing the confidence of students and their parents in the quality of education in Singapore, we will enter into a standard PEI-Student Contract with all our students.
- (b) The contract lays out the important terms and conditions governing the relationship between the student and IMSC. We will honour the terms and conditions spelt out in the contract and in all communication materials. A copy of the standard student contract is available for inspection upon request and also on the CPE website (www.ssg.gov.sg/cpe/pei.html).

Refund Policy

- (c) The Student will be entitled to a refund of the entire Course Fees and Miscellaneous Fees already paid, save the non-refundable application fees, should the Student decide to withdraw, within 7 working days of the following notice:
 - i. IMSC does not commence the Course on the Course Commencement Date;
 - ii. IMSC terminates the Course before the Course Commencement Date;
 - iii. IMSC does not complete the Course by the Course Completion Date;
 - iv. IMSC terminates the Course before the Course Completion Date;
 - v. IMSC has not ensured that the Student meets the course entry or matriculation requirement(s) as set by IMSC in Course Details within any stipulated timeline set by CPE;
 - vi. The Student's Pass application is rejected by the Immigration and Checkpoints Authority (ICA).
- (d) IMSC will provide the Student with a cooling-off period of 7 working days after the date that the Student Contract has been signed by both parties. The Student will be refunded the highest percentage of fees already paid if the Student submits a written notice of withdrawal to IMSC within the cooling-off period, regardless of whether the Student has started the Course or not.
- (e) If the Student withdraws from the Course for any reason other those stated in (a), IMSC will, within 7 working days of receiving the Student's written notice of withdrawal, refund to the Student an amount based on the following:

Fee Protection Scheme

- (f) The Fee Protection Scheme (FPS) serves to protect students' fees in the event a PEI is unable to continue operating due to insolvency, and/or regulatory closure.
- (g) The Fee Protection Scheme also protects students if the private education institution fails to pay penalties or return fees to the students arising from judgement made against it by the Singapore courts.
- (h) The FPS is applicable to ALL students (regardless of nationality and the type of passes, i.e. dependent's pass, student's pass, work permit etc).
- (i) IMSC has appointed Lonpac Insurance Bhd to be the FPS provider for all students.

- (k) It is compulsory for ALL international students to purchase IMSC's Group Medical Insurance plan which provides coverage for hospitalisation, outpatient and related medical treatment for the entire course duration.
- Singaporeans, Permanent Residents and non-Student Pass holders are exempted if they are covered by their own medical insurance plan.
- (m) Students who choose to opt out of the medical insurance are to show proof that they have their own medical insurance. Please speak to the programme consultant in order to make informed choices.

Advisory Note

The PE Act also requires a student to sign an Advisory Note prior to enrolling to the chosen PEI. The advisory note will be signed and returned together with the PEI-Student Contract.

- I hereby declare that all the particulars furnished by me in this application are true and correct.
- I undertake not to study without a Student's Pass
- I undertake not to misuse controlled drugs or to take part in any political or other activities during my stay in Singapore which would make me an undesirable or prohibited immigrant under the Immigration Act.
- I undertake to comply with the provisions of the Immigration Act and any regulations made thereunder or any statutory modification or re-enactment thereof for the time being in force in Singapore.
- I undertake not to be involved in any criminal offences in Singapore.
- I undertake not to indulge in any activities which are inconsistent with the purpose for which the immigration passes have been issued.
- I further undertake not to be engaged in any form of employment or in any business, profession or occupation in Singapore whether paid or unpaid, without a valid work pass issued under the Employment of Foreign Manpower Act (Cap. 91A). I understand that industrial attachment and/or on-the-job training (whether provided by my school or otherwise) is also considered as employment under the Employment of Foreign Manpower Act and requires a valid work pass.
- I am aware that overstaying or working illegally in Singapore is a serious offence and on conviction, the penalties may include mandatory imprisonment and caning.
- I understand that if the Controller of Immigration is satisfied that I or any member of my family breaches this undertaking or becomes an undesirable or prohibited immigrant, he will cancel my immigration pass and the passes of the members of my family, and we may be required to leave Singapore within 24 hours of such a cancellation.
- I give my consent for the Immigration and Customs Authority of Singapore to obtain and verify information from or with any source, as you deem appropriate for the assessment or my application for immigration facilities.
